The Departments of Behavioral Health of both Riverside University Health System and San Bernardino County are requesting that we maintain our Members in treatment with our Network Providers versus transitioning to the County for Tier III level of care.

The County Mental Health Plans are currently experiencing limited resources and do not have the capacity to process transitions from the Managed Care Plans to their system. **Please continue to treat and support the Member therapeutically until resources are available to transition to their respective County Behavioral Health Departments.**

You may still submit a recommendation to transition to County Behavioral Health through the Coordination of Care Form on the BH Web Portal. The IEHP Behavioral Health County Liaison team will continue working with both County Behavioral Health Departments to transition these Members as soon as possible.

For Prescribing Providers who are unable to refill psychotropic medications, you may send Members to the IEHP Psychiatry Walk-In Clinics until they are able to schedule a follow-up appointment with you:
